



The Board of Directors of IBS Ljubljana International Business School, on the basis of the Regulation on Tuition Fees and Other Contributions in Higher Education (Official Gazette of the Republic of Slovenia, No. 157 of 16 December 2022), at the meeting of the Board of Directors of IBS Ljubljana International Business School on 16 February 2023, adopted a decision on tuition fees and contributions for the academic year 2023/2024, which reads as follows

Examination fee for students not enrolled - Master's degree for 10 ECTS	1.000,00
Diploma fee for students not enrolled - Master's degree	1.000,00
Duplicate diplomta, other documens	50,00
Repeat of year/graduation year	1.000,00

\*The fee is charged for each new academic year.

#### Contributions for:

- Cost of further examinations in the same subject,
- the cost of board examinations,
- costs related to the implementation of the study programme in the field and professional excursions (transport, accommodation, etc.),
- membership fees for higher education libraries,
- other study contributions to the extent necessary for the implementation of the study programme (use of ICT equipment, student interest activities, etc.),
- shall be charged to students at the actual material cost.



The tuition fees and additional services for one year in the academic year 2023/2024 can be paid by self-payers in 10 instalments without interest. Legal persons normally pay tuition fees and additional services in one instalment. Foreigners pay tuition fees and additional services in one instalment. There is a fee of € 50.00 for the approval of instalment payments, which you pay together with the 1st instalment and the registration fee at the time of enrolment. The instalment for the 1st or 2nd or 3rd year is 1/10 of the tuition fee and additional services charged.
